Through a series of actual case examples, participants develop skills assessing and managing threats of intended violence.

- Explain how to identify circumstances and context
- Recognize and accept positive and negative intelligence Risk Enhancement and Risk Reduction
- Review BC Sheriff Services Threat Assessment format for intended violence
